BOARD UPDATE

- Mrs. Marietta reported that the BRACA Easter Egg Hunt at Shawnee Park had a huge turnout and fun was had by all.
- Mrs. Callahan announced that the online preregistration for the Hall of Honor Auction will be going live on April 13, 2018. She also mentioned that they were still collecting baskets and suggested that if you wanted to donate a basket, it needed to be done soon. Tickets were still available from Mrs. Marcus, Mrs. Stafford and Dr. Woodruff.
- Mr. Spahr reported that attendance has been soaring with the new superintendent at the Greene County Career Center, and that they were expecting it to increase more next year. He stated that they had received a grant from the state to help facilitate the aeronautical project underway; and that they are continuing to see improvements all around. After the storms that went through the area in the past week, FFA students and leaders from Xenia reached out to help provide clean up and meals for the farmers who sustained damage. Mr. Spahr announced that on Friday, April 13, 2018, the first home track meet will be held at Cox Stadium in years. Due to the new track being installed, they are expecting many more to come. He also reported that the new league will be meeting on April 11th, and that
